Stockdale Road PS **Grey Street PS**

The Little Village Project (LVP) is a communityled initiative to support vulnerable children in the Latrobe Valley. Founded in 2020 by Ben Tunks, the Wellbeing Support Officer at Stockdale Road Primary School, the project strives to collaborate with primary schools to empower their vulnerable students and help them thrive.

Auspiced by Kindred Spirits Enterprises, the LVP began at Stockdale Road under Ben's guidance and since then it has supported more than 70 students by offering a range of services, including mental health care, speech therapy, and sensory support.

These interventions eliminate barriers to the students' engagement at school, enabling them to actively participate in classes and other activities, ultimately fostering a brighter and more promising future for each child.

In late 2022, the LVP secured a three-year partnership with the Latrobe Health Assembly, facilitating its expansion to additional schools in the Latrobe City Local Government Area. AGL Loy Yang also committed to a three-year funding partnership, further enabling the project's growth and sustainability.

Thanks to the sustained support of these organisations, the LVP expanded to Grey Street Primary School in mid-2023, with plans for further expansion in 2023-24. In addition to this, planning for the first LVP fundraising commenced with and is scheduled to be held in September 2023.

Case Study - Jane

In the very early days of The Little Village Project, we met a student, Jane*, who had transferred from another school to Stockdale Road Primary School. She was in Grade Six and incredibly shy - in fact, we barely heard Jane speak for the first few months she was with us. Jane was a diligent and hard-working student who gave her all to her learning. Over time, we discovered that the reason Jane was so quiet was that she felt ashamed of a speech and language issue that made it difficult for her to say "r" and "l" sounds.

The Little Village Project funded Speech Therapy sessions for Jane, which the school supported with its Speech Therapy Assistant Program. The student enthusiastically engaged in these sessions as though she had been holding out for an opportunity like this.

With a lot of hard work and persistence. Jane's speech and language improved and we watched as she grew in confidence. She began making eye contact instead of looking at the ground and she would contribute her wonderful ideas to class discussions. Most importantly, we began to see Jane smile.

She is in secondary school now. However, I was lucky enough to run into her at the shops recently. Jane bounded up to me and said hello, brimming with confidence. The money spent on Speech Therapy was worth every cent.

Australian Sustainable Hardwoods By working hand-in-hand with businesses across Gippsland, the Shared Value Initiative is assessing the social and financial returns on investing in workforce mental health.

Given the high rates of mental illness in regional Australia, there is tremendous opportunity to improve mental health and business performance by investing in evidence-based mental health training delivered by the Black Dog Institute (BDI).

Working alongside Kindred Spirits Enterprises, the BDI provides mental health training to businesses across Gippsland. These workplaces can then implement a more positive working environment for their staff, resulting in reduced stress and absenteeism and greater achievements in their assigned tasks.

Funding

2022-23

The project will conclude at the end of 2023, with BDI evaluating the effectiveness of the workshops and the impact on participants. Early findings show a positive response to the workshops from participating businesses.

Meeniyan **25** Participants Regen Gippsland (RG) is a platform for ambitious collaboration, in service to Gippsland, and is powered by a growing alliance of organisations. The aim is to build and foster a connected regional network of organisations to strengthen regional social, environmental and economic outcomes for Gippsland. It acts as an alliance of individuals and organisations committing their skills, resources and aspirations to reinvent Gippsland.

RG was able to find a formal auspicing body, Kindred Spirit Enterprises, and secure funding for a 6-month pilot (May - Oct 2023). The ambition of the pilot was to develop preliminary community insights around a regenerative future for Gippsland and surface recommendations for our road ahead. This has been achieved through initial high-level

research and mapping, and community consultation with individuals.

At the core of our community engagement process were three community design forums, each covering a particular emerging theme in relation to the place. These workshops each addressed the opportunity and aspirations of place, acknowledge existing local initiatives and champions, and explored the theme in relation to the Doughnut (see next page).

Kindred Spirits Enterprises will continue to act as the auspicing body for a further 12 months into 2024 and commit further resourcing towards the backbone function. This support will enable further development of the alliance and build capability.











Doughnut Economics



Doughnut Economics is a concept and economic model introduced by economist Kate Raworth. It offers an alternative framework for economic development that seeks to balance human well-being with ecological sustainability.

The model envisions an economic "doughnut" shape, where the inner ring represents the social foundation, ensuring that all people have access to essentials such as food, healthcare, and education, without falling into poverty.

Meanwhile, the outer ring represents the ecological ceiling, defining the environmental limits beyond which human activities risk causing irreversible damage to the planet.

The goal of Doughnut Economics is to find a balance between meeting the basic needs of all individuals and staying within the ecological boundaries of the Earth. It encourages a shift from the traditional growth-centric economic approach to one that prioritises sustainability, social justice, and well-being.

Kurnai Young Parents Program Mentoring Initiative

The Kurnai Young Parents Program (KYPP) offers 14-20-year-old students the opportunity to complete their schooling in a safe and supportive environment while facing the challenges of being a young parent.

Operating at the Kurnai College Flexible Learning Option campus in Morwell, the free program provides students with numeracy, literacy, personal development and life skills and the opportunity to work towards a tailored pathway through a flexible learning program.

Kindred Spirits Enterprises (KSE) and Kurnai College are working together to expand the KYPP to include a mentoring component, enhancing the current program. The KYPP team discovered a need to provide ongoing support to students either undertaking or who have completed the course.

Many students have narrow and limited support networks and frequently deal with complex and challenging issues and

relationships, impacting their ability to set and achieve goals. A mentor program will add value to the existing course, complement the program's philosophy and help contribute to the ongoing development of program participants.

KSE, in partnership with Kurnai College, is currently undertaking scoping work to identify a suitable mentoring program that can be adapted to complement the existing KYPP. This scoping work was made possible thanks to a generous donation from the Latrobe Health Assembly.

Bike Racks for Buses is a social enterprise focused on providing bike racks for use on public buses across Victoria.

The project was originally conceived to employ long-term, multi-generational unemployed residents from across the Latrobe Valley to assemble the bike racks, and encourage active living among Victorian residents.

Operated in partnership with the Bus Association of Victoria, this project has helped to fund social impact projects currently led by Kindred Spirits Enterprises (KSE).

In early 2023, KSE made the decision to cease its involvement in the enterprise, which will take effect from November 2023. The Board has decided that the enterprise no longer aligned with KSE's mission and vision, and other enterprises will be pursued.

Marri Tjevin Language Project

Experienced linguists, led by Gregor Renwick, are working closely with the Rak Thanggarral to record the words, sentences and stories of the Marri Tjevin people in the Northern Territory.

The project includes recording native speakers, compiling these recordings into a dictionary, translating stories into Murrinhpatha and English and creating learning resources.

Workshops will be held with the Rak Thanggarral regarding the future use of existing and newly created assets, enabling Rak Thanggarral ownership and platforms for access for their desired audience. Marri Tjevin families play an integral part in the project and work with the linguists to further develop ways to strengthen, share and celebrate their important connections through Culture and language.

Kindred Spirits Enterprises has supported Gregor's work for several years through annual funding contributions and in-kind support. This will continue.
